## WPPA Image Judging and More

---

The WPPA Image Competition is designed to further your education in the areas of technical excellence and understanding of an exceptional image that may set you apart from other photographers.

Images entered are judged against 5 elements.

Jurors use these 5 elements to deem whether an entry has met or exceeded the level of a high-quality professional image.

**Impact**  
**Technical Excellence**  
**Creativity/Style**  
**Composition**  
**Presentation/Title**

### Scoring Scale

Images entered into the WPPA Image Judging and More can receive scores up to 100 points, dependent on how they meet the Elements of a Merit Image.

100 - 95	Exceptional
94 - 90	Superior
89 - 85	Excellent
84 - 80	Deserving of a Merit
79 - 75	Above Average
74 - 70	Average
69 - 65	Below Exhibition

**Impact** - Is the image compelling? Does it evoke a discernible emotion that is relevant to the story and category? Impact can be immediate, fleeting and/or lasting.

**Technical Excellence** - Does the image excel in objective technical areas such as exposure, color balance, lighting, dynamic range as well as being absent of other technical flaws such as dust spots, moiré, chromatic aberration, banding, clone tracks and the like.

**Creativity/Style** - The image is original, fresh, and an external expression of the maker's imagination. Is the subject matter right for the story that you are telling. Jurors may also consider any techniques that are used to best express the story of the image.



**Composition** - The visual elements of an image come together to express intent, whether that's to please the viewer or otherwise. The viewer's attention is captured and directed where the artist plans it to be. Jurors may also consider whether the subject matter is relevant and central to the story being told.

**Presentation/Title** - How you showcase an image is just as important as how you compose it. The title and everything in the presentation should work to enhance your image and not distract from it. Choose mats, borders and the proper title. Keep titles short and to the point, and understandable.

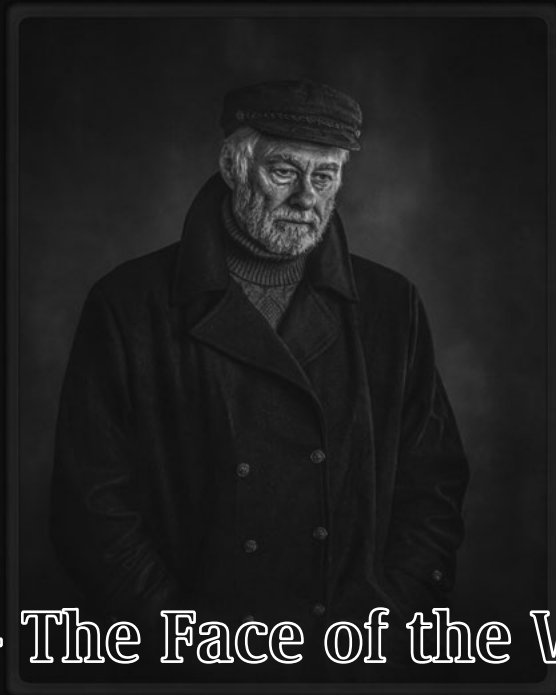
# 100-95 Exceptional Score

---

Scoring an image between 95 and 100 in an image competition is considered exceptional and requires the image to possess several key attributes. Some of these attributes are:

---

1. **Technical Excellence:** The image should have excellent sharpness, exposure, color balance, and other technical qualities that demonstrate a high level of technical proficiency.
  2. **Composition:** The image should have a well-balanced and aesthetically pleasing composition that draws the viewer's eye and captures their interest.
  3. **Creativity:** The image should showcase the photographer's unique perspective and creative vision. It should be original, thought-provoking, and visually impactful.
  4. **Emotion:** The image should evoke an emotional response from the viewer, whether it be awe, wonder, humor, sadness, or any other emotion.
  5. **Storytelling:** The image should tell a story or convey a message that engages the viewer and adds depth to the image.
  6. **Impact:** The image should have a strong visual impact that makes it stand out from other images and leaves a lasting impression on the viewer.
  7. **Quality of Print:** For print competitions, the quality of the print itself should be excellent, with accurate color, good contrast, and clean whites and blacks.
- In summary, an exceptional scoring image should possess a combination of technical excellence, creativity, and emotional impact, and should be well-composed and visually appealing.

## 94-90 Superior Score

---

Scoring an image between 90 and 94 in an image competition is considered to be a Superior Image.

---

The scoring of an image in a competition is usually determined by a panel of judges or a set of criteria established by the competition organizers.

The specific criteria used can vary greatly between competitions, but some common elements include technical excellence, composition, impact, creativity, originality, and overall presentation.

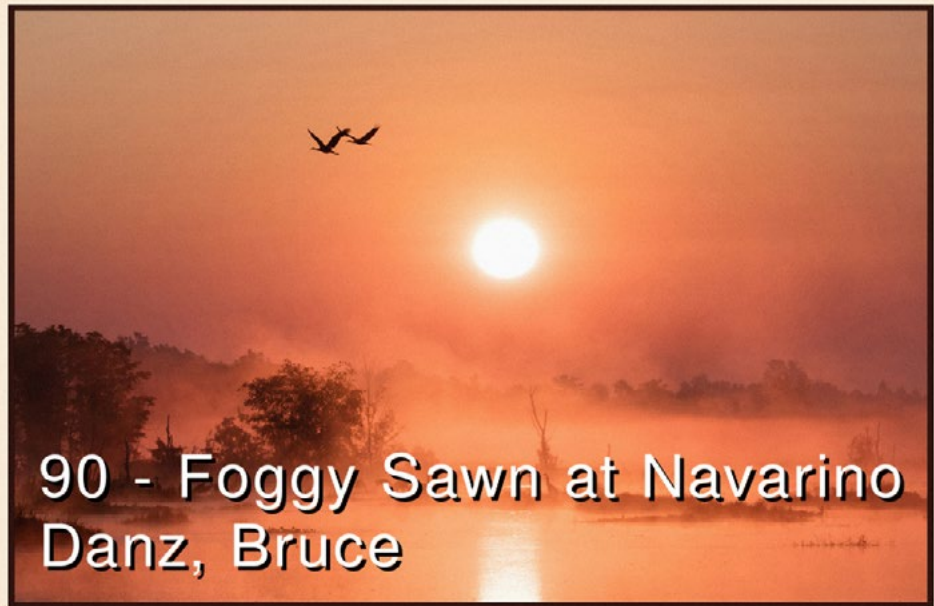
When an image scores between 94 and 90, it means that the judges considered the image to be of high quality, but perhaps not quite reaching the highest level of excellence.

The reasons why the image did not score higher could be many, ranging from minor technical flaws or inconsistencies in composition to a lack of impact or originality compared to other images in the competition.

It is important to keep in mind that scoring in a photography competition is highly subjective and can be influenced by personal preferences and biases of the judges.

The most important thing is to keep learning and improving your craft, and to enter your work in competitions as a way to gain recognition and exposure.

## 89-85 Excellent Score

---

A score between 85 to 89 in an image competition usually indicates that the image has been rated as “excellent” and is of high quality. The exact criteria for scoring in an image competition can vary, but generally, the judges are looking for a combination of technical and aesthetic elements, including:

---

- **Composition:** How well the elements in the image are arranged and balanced

For example, the image might be slightly overexposed, or the composition may not be as strong as it could be.

- **Exposure:** Whether the image is properly exposed with good contrast and tonal range

Alternatively, the judges may simply have preferred other images in the competition that had a slightly higher level of excellence.

- **Focus:** Whether the image is sharp and in focus

- **Color:** How well the colors in the image complement each other and convey mood and emotion

In conclusion, the score between 85 to 90 is a high score and indicates that the image is of excellent quality, but there are still areas for improvement that could have pushed the score higher.

- **Originality:** How unique and creative the image is

- **Technical skill:** How well the photographer has used their equipment and post-processing techniques to achieve the final result.

If an image scores between 85 to 90, it may not have scored higher due to small imperfections in one or more of these areas.

## 84-80 Deserving of a Merit

---

In general, a score of 80 to 84 means that the image is of high quality, but it may have some minor flaws or weaknesses that prevent it from scoring higher. Some common reasons why an image might not score higher despite being deserving of a merit include:

---

- **Technical Issues:** The image might have some technical imperfections, such as poor focus, incorrect exposure, or noise, that detract from its overall impact.

- **Composition:** The image might have a strong concept, but the composition may be less than optimal, resulting in a lower score.

- **Impact:** The image might be visually appealing, but it might not have the emotional impact or visual impact that the judges are looking for.

- **Originality:** While the image might be well-executed, it may not be sufficiently original or unique, which can prevent it from scoring higher.

These are some of the reasons why an image might not score higher despite being deserving of a merit.

However, it's important to keep in mind that photo competition scores are subjective, and the judges' opinions and preferences can play a role in the final scores.

## 79-75 Above Average

---

The exact criteria for scoring in an image competition can vary depending on the competition rules and the individual judges. However, in general, a score of 75 to 79 indicates that the image is considered to be above average in terms of technical merit and visual impact, but there may be some areas for improvement.

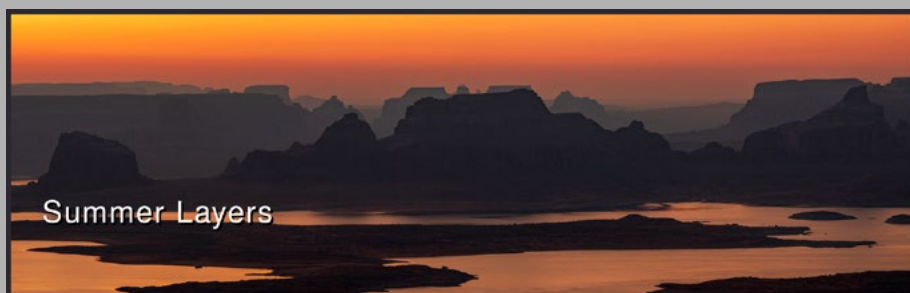
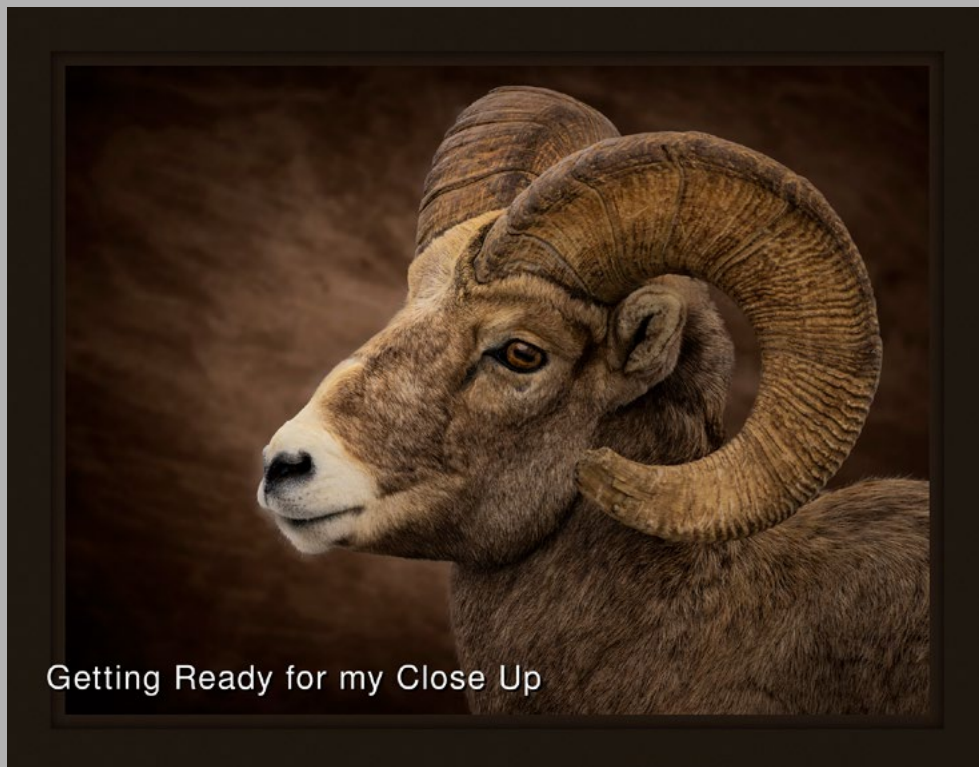

**The reason the image did not score higher could be due to various factors such as composition, lighting, color balance, focus, or any other technical aspect of photography that the judge felt needed improvement.**

**It could also be that the image did not fully meet the criteria for the particular category of the competition, or that it did not stand out compared to other high-scoring images in the competition.**

**It's important to keep in mind that image competitions are subjective and the opinions of different judges can vary.**

**A score of 75 to 79 is still a very good score, and it shows that the image has many strengths and is well above average.**



# Senior Folio Competition

---

Senior photographers we have a different competition that you maybe interested in. It is called our Senior Folio Competiton. WPPA Members have a chance to earn the title of Senior Photographer of the Year.

---

## Please review thoroughly!

1. A Folio is created with at least **8 portraits** of a high school senior. The digital file must be cropped to a 10x20 with a dpi of 4000 for the longest dimension.
2. Folios will be looked at as a body of work. When scoring, judges will use the judging elements as normal but also weigh the sale ability, variant, posing, creativity and consistency across the poses shown.

### Senior Folio Competition Categories

You must designate one of the below categories for each entry.

- Senior Boy
- Senior Girl

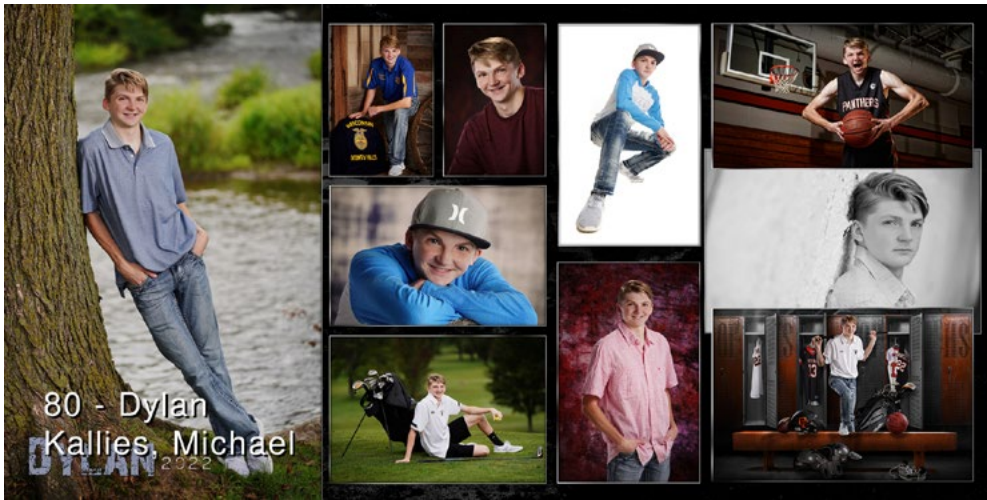
## Senior Photographer of the Year

- 1st Place
- 2nd Place
- 3rd Place

Awarded to the individual photographer who has the highest scoring Case total in the Senior Folio Competition. If there is a tie, the title is awarded to each individual.

**Case scores are determined** by adding the 4 highest scoring Folios in the Senior Folio Competition. The case total must have a score of **320 or above to be eligible**.

- Entry Deadline is Midnight Central Time, on Thursday, **February 29, 2024**.

## WPPA is holding **THREE** Competitions.

### Photographic Open Competition

### Artist Competition

### Senior Folio Competition

- Everyone is encouraged to enter.
- Everyone is eligible to win the Sponsored Awards (Only 1 Sponsored Award is allowed per entrant.)
- Current WPPA Members are eligible to win the WPPA State Awards. You must have renewed your 2024 Membership or Joined WPPA before you enter the 2024 Image Judging and More. (See WPPA Membership application and the 2024 WPPA State Award Rules for more information.
- Entrants may enter unlimited entries in each of the three competitions.
- The entry fee is \$15 per individual entry.
- Entrants may pay an **additional \$30 for image discussion** that takes place the day of the judging and is recorded, **one fee** for all of the images that you have entered into any of the competitions. Please allow 2 weeks following the completion of the competition for the upload of the discussions to [printcompetition.com](http://printcompetition.com).
- Entries include any combination of digital entries and digital album entries.

## General Rules

These rules pertain to all three competitions.

1. All entries must be registered at [www.printcompetition.com](http://www.printcompetition.com). There is a separate fee payable to PrintCompetition for use of their service.
2. Entrants may only submit digital images for judging.
3. Entrants may enter unlimited images in each competition.
4. A minimum of 4 entries may be required to be considered for top awards in each competition (see awards rules).
5. No changes to your entry are permitted once the entry deadline has passed. No refunds will be issued after the entry fee is paid.
6. Eligible images include:
  - a. Images that have received a Merit or Imaging Excellence score in Merit Image Review (MIR).

- b. Images that were entered into IPC, but did not received a TOP 32 designation.
  - c. Fresh images that have not yet been entered into a competition.
  - d. Images that have been entered into a previous WPPA Image Judging and More that have not received a score of 80 or higher.
  - e. Images from other image competitions, except those excluded below.
7. Image that are NOT eligible include:
  - a. Images that have been selected for the World Cup competition.
  - b. Images that have received a TOP 32 designation in any IPC category.
  - c. Images that have received a WPPA State Award.
  - d. Images that have received a 80 or higher in a WPPA Competition.
8. AI STATEMENT: No entry in any category or competition can be created in part or whole using Artificial Intelligence (AI) technology software that is intended to create whole images, backgrounds and other elements entirely from programmed images. A human must have had creative control over the work's expression. Images and their elements must be created with traditional elements of authorship.
9. Entrants do not need to be WPPA members to compete in the WPPA Image Competitions for Sponsored Awards. (ONLY 1 sponsored award is allowed per entrant.)
10. WPPA members may be eligible for WPPA State Awards and fellowship merits. (See the WPPA Awards Rules)
11. All entries must have a Title, chosen by the maker.
12. The entrant has obtained and has access to all necessary releases (model or property) and agrees to hold WPPA harmless against all claims and liabilities arising out of WPPA's display, publication, promotion, or other use of each image submitted to WPPA.
13. The entrant's name shall not appear anywhere in or on the face of the entry.
14. Entry media includes digital files and digital albums. A case includes any combination of digital entries and digital album entries up to the maximum allowed in a case.
15. No entry will be eligible if it has been made under the supervision of an instructor or as a class assignment. All images submitted must be self-directed. Images created in an educational environment under direct supervision from an instructor are ineligible.
16. Entries of the same subject in multiple images will be allowed, as long as the images are substantially different, including background, location, clothing, and concept. The same subject rule applies across all three competitions and all cases submitted by an entrant in a given year. For example, you may not use the same subject, background, location, clothing, and concept in both Photographic Open and Artist competitions. The same subject rule also applies to an individual image and an album (if that subject, background, location, clothing, and concept appears in an album, it cannot also be entered as an individual image).
17. If an entry, in the good-faith opinion of the WPPA Competition Committee, violates copyright, trademark, or any other applicable law and cannot be proven otherwise, that entry shall be disqualified and trophies, awards, and WPPA Fellowship Merits revoked, if issued.

## **Digital Submission Specifications**

- Files must be sized so the longest dimension is 4000 pixels. Each file must contain an embedded color profile of either sRGB or Adobe RGB1998 and be saved at a JPEG quality setting of 10. In most cases, the total file size should not exceed 3.5 MB. Larger files will be accepted when necessary so long as they are JPG/10.
- Files are to be named, use the title of the image only.

## **Digital Album Entry**

All albums must be submitted in digital form.

1. All page/spread files must have the longest file dimension at 4000 pixels, have an embedded color profile of either sRGB or Adobe RGB1998, and saved at a JPEG quality setting of 10.
2. Each page/spread file may contain as many images as you desire.
3. An entry shall contain a minimum of 5 page/spread files up to 36 page/spread files.
4. Files are to be numbered in viewing order using two digits, i.e. 01 jpg, 02 jpg, 03 jpg, etc.
5. All individual files must be compressed into a single ZIP file. ZIP file must be named: Album Title.zip (e.g. Summer Wedding.zip).
6. Studio identification or entrant's name cannot appear on any file within the album entry.
7. Each entrant must use the same title when entering a multi maker album.

## Photographic Open Competition Rules

The Photographic Open Competition is to show the photographic knowledge and skill set of the entrant. This competition is for all images and albums where the entrant is responsible for creating the images of the primary subject(s) of the final entry. See additional rules for categories such as Wedding Competition Rules and Reportage.

1. Entrant must have captured and created the original exposure or exposures.
2. An Entrant can use supporting photographic elements that they did not create, provided those elements are referenced as guide images on the face of the entry. The original photographic capture by the entrant should be merit-worthy independent of the work that was not their own. Elements created by the entrant must not be part of the guide images. This applies to image within an album entry also.
3. All processing, manipulation, and printing or rendering, were done by the entrant or under their direct supervision.
4. The entrant has obtained and has access to all necessary releases (model or property) and agrees to hold WPPA harmless against all claims and liabilities arising out of any WPPA's display, publication, and promotion or other use of each image submitted wot WPPA's Image Judging and more.
5. The entrant's name shall not appear anywhere in the entry.
6. No entry will be eligible if it has been made under the supervision of an instructor or as a class assignment. All image submitted must be self-directed. Images created in an educational environment under direct supervision from an instructor are ineligible.
7. Any entry that has been created from an existing photograph, portrait, graphic, or any other artwork produced by another person is a violation of the competition rules and will not be judged, accepted, or displayed. If an entry, in the good-faith opinion of the WPPA Competition Committee, violates copyright, trademark, or any other applicable law, that entry shall not be displayed or published.
8. Entries of the same subject in multiple images will be allowed, as long as the images are entirely different concepts.
9. Entries with guide images are still entered into the appropriate category: Portrait, Illustrative, Album, etc.
10. Artificial Intelligence (AI) No entry in any category or competition can be created in part or whole using Artificial Intelligence (AI) technology software that is intended to create whole images, backgrounds and other elements entirely from programmed images. A human must have had creative control over the work's expression. Images and their elements must be created with traditional elements of authorship.
11. Entry media includes digital files and digital albums. A case includes any combination of digital entries and digital album entries up to the maximum allowed in a case.

## Photographic Open Categories

Photographic open consists of the following Categories.

- ***PORTRAIT***
- ***ILLUSTRATIVE***
- ***LANDSCAPE***
- ***WILDLIFE***
- ***COMMERCIAL***
- ***REPROTAGE***
- ***WEDDING Day***

## Photographic Open - Categories and Sub-Categories

You must designate one of the below categories/sub-categories for each entry:

**PORTRAIT** - Consists of Natural Portrait Images using structured lighting in a studio or outdoor environment. They can portray a subject or subjects from all walks of life and should reflect the personality of the subject(s).

- Portrait Sub-Categories:
  - o **General Portrait** – Includes Families, groups, adults, couples, fashion, boudoir.
  - o **Children/Baby** – 0 to 16 years
  - o **Couple** – Non-Wedding
  - o **High School Senior** – Age 16 to 18
  - o **Animal** – Animal portrait using structured lighting in a studio or outdoor environment. The owner or the photographer is in control of the animal and lighting.

**ILLUSTRATIVE** - Consists of pictorials, abstracts, composites, digital paintings, flowers, plants, trees, macro, zoo animals and similar subject matter.

- Illustrative Sub-Categories:
  - o **Composite**
  - o **Digital Painting**
  - o **Nature**
  - o **Illustrative Portrait** - Images where styling, creative photo techniques, extensive makeup or props are allowed. Postproduction techniques are encouraged and may be an essential part of the final story in the photograph. Entries in this category would include images that have been highly manipulated or stylized.
  - o **Illustrative Open**
  - o **Album** - consist of non-wedding, social events, such as bar mitzvahs, etc., or albums of portraits and other storytelling albums.

---

**LANDSCAPE** - This category is for photography that is devoted to displaying natural elements such as landscapes, cityscapes, seascapes, aerial, and astrophotography.

- Landscape Sub-Categories:
  - o Drone/Aerial
  - o Astrophotography
  - o Landscapes

**WILDLIFE** - Images of wildlife in a natural habitat. This category is not for composites.

- Wildlife Sub-Categories:
  - o Birds
  - o Animals
  - o Reptiles
  - o Insects

**COMMERCIAL** - Images with an intended use by a commercial client to promote or brand a product or company. Advertising, fashion, beauty, still life, food, architecture, corporate photography is all included in this category. Composite and non-composite images, light painted, and highly manipulated images.

- Commercial Sub-Categories:
  - o Food
  - o Fashion/Beauty
  - o Architecture
  - o Commercial Open

**REPORTAGE** - Images that illustrate an actual public or non-public event, life, an area of human interest, telling news that have meaning on the context or record of events, high impact and/or lasting emotional response. Images that illustrate sporting events are included in this category.

- Reportage Sub-Categories:
  - o Reportage Open

**WEDDING** - The Wedding Category is for all images and albums created by the entrant under the time constraints of an actual wedding event. Jurors will keep in mind that the maker has limited control over many aspects of a wedding, including the subject matter, environment, and time of day. Images should include some kind of visual wedding reference(s).

- Entrant must have captured and created the original exposure or exposures.
- All images and all elements of an image must have been made during the course of an actual wedding event. Images not created during the time constraints of an actual event (such as engagement or bridal portraits) must be entered in a different competition.

---

- Wedding Sub-Categories:
  - o **Wedding Day Open** - Images eligible in the Wedding Open category must be created during the time constraints of the actual event.
  - o **Wedding Day Album** - All images included in the Wedding Album must be created during the time constraints of the actual wedding event. You may enter as a single maker or a multi-maker; (2) photographers creating a minimum of twenty images each from the same wedding. Please Note: Failure to comply with these rules may result in disqualification of the entry.

## Artist Competition Rules

Please review thoroughly!

The Artist Competition allows the maker to demonstrate their art skills and expertise in the creation of an image made from one or more sources. The maker is not required to have photographed any of the source images. Entries will be judged for digital, artistic, and technical proficiency. Entries can be created using digital or traditional art (such as painting and airbrush) or a combination of both.

1. Entries may be reproduced from existing photographs, portraits, graphics, or any other artwork so long as the entrant is prepared to provide appropriate written documentation indicating permission for usage. This documentation may be requested by WPPA before, during, or after the competition.
2. All processing, manipulation, artwork, or rendering must be done by the entrant.
3. Guide images must be included on the submitted digital canvas.
4. Any Artificial Intelligence (AI) images used in the Creative Open Artist entry must be included in the guide images.
5. A Single Artificial Intelligence (AI) image on its own will not be accepted into the Creative Open Artist Competition. AI can be part of a creative open image as long as there is a guide image on the canvas.
6. Entry media is single digital files up to the maximum allowed in a case.
7. Artificial Intelligence (AI) No entry in any category or competition can be created in part or whole using Artificial Intelligence (AI) technology software that is intended to create whole images, backgrounds and other elements entirely from programmed images. A human must have had creative control over the work's expression. Images and their elements must be created with traditional elements of authorship.

## Artist Competition Categories

You must designate one of the below categories for each entry.

- **CREATIVE OPEN ARTIST:** These are works created by the entrant from any combination or original photographs or other art sources.
- **RESTORATION:** These are works created by the entrant from original, damaged photographs.

1. A Folio is created with at least 8 portraits of a high school senior. The digital file must be cropped to a 10x20 with a dpi of 4000 for the longest dimension.
2. Folios will be looked at as a body of work. When scoring, judges will use the judging elements as normal but also weigh the sale ability, variant, posing, creativity and consistency across the poses shown.

## Senior Folio Competition Categories

You must designate one of the below categories for each entry.

- Senior Boy
- Senior Girl

- The Image Competition Committee has the right to move an image to a different competition/category/sub-category if they feel it has not been put into a proper competition/category/sub-category by the maker/entrant.

## **WPPA Members State Awards - Awarded by Other Organizations**

### **The ASP (American Society of Photographers) State Elite Award**

- Presented to the ASP member in good standing for the highest scoring entry at his or her State Image Competition. This means that he or she is a member in good standing with WPPA as per our Bylaws and that he or she must be current with their ASP dues PRIOR to the competition.
- In the event of a tie, total case score will be the first tiebreaker.
- In the unlikely event that a tie still exists, the second highest scoring entry in the case will break the tie. In the really unlikely event that a tie still exists, the third highest scoring entry will break the tie. If by the remotest chance a tie still exists, ASP will declare co-winners of the award and provide an additional trophy. Both recipients should be duly recognized at the awards ceremony for their accomplishments.
- An ASP member is eligible for the State Elite Award only in the state in which he or she resides, or the state listed as their primary affiliation.
- The State representative from ASP will do the presentation of the ASP Best of the Best video and the award.

### **CPP Award from PPA**

Awarded to a current Certified Professional Photographer WPPA member with the highest scoring image. If there is a tie, the next image in their case will break the tie. Winning entry must have a score of at least 80 (deserving of a merit) to qualify.

### **AIM (Animal Image Makers) Trophy**

Wildlife, Canine, Cats, Domestic and Exotics, Equine, Lizards, fish, birds, guinea pigs, snakes, Farm Animals etc. Wild & Zoo Animals, Birds, and Insects. You could have captured the image as a portrait or from an African safari, trip to the zoo, trip to the swamp or in your yard.

The AIM trophy is to be awarded to the highest scoring animal image in the competition. If there is a tie, judges will decide on the winning entry. Winning entry must have a score of at least 80 (deserving of a merit) to qualify.

\*WPPA Print Committee of uninvolved members will be the final decision on any issues/ questions that may arise.

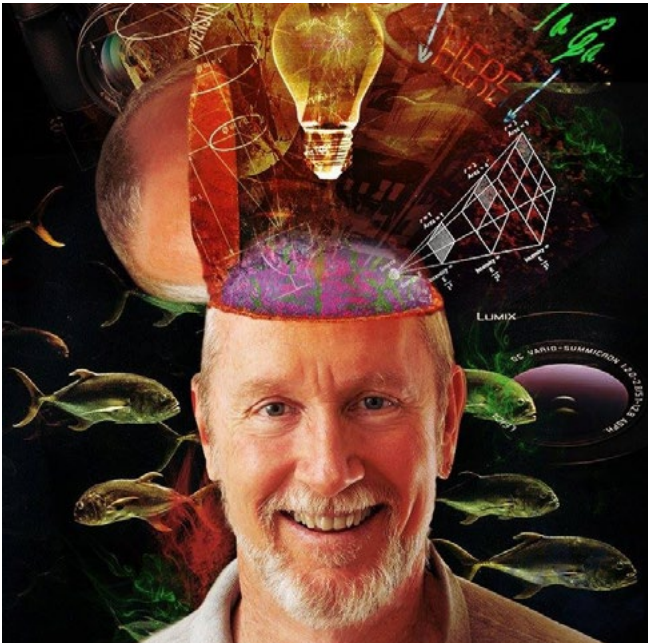
Toni was a Diamond photographer of the year at IPC 2020 and 2021 and is a past GIA nominee.

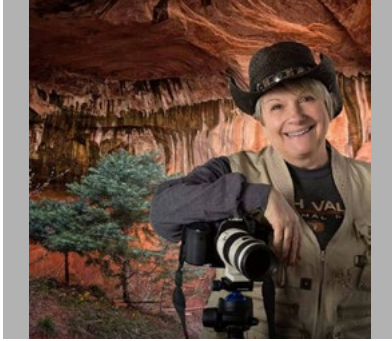

#### One way to create a digital frame in Photoshop, follow these steps:

1. Open Photoshop and create a new document with the desired size and resolution.
2. Use the rectangular shape tool to draw a frame. You can change the shape's color by clicking on the „Paint Bucket“ tool in the toolbar, selecting the desired color and then clicking on the frame.
3. If you want to add a stroke (outline) to the frame, go to the Layers panel, right-click on the layer with the frame, and select „Layer Style.“ In the Layer Style dialog box, click on „Stroke“ and choose the desired size, color, and position of the stroke.
4. To add a drop shadow to the frame, repeat step 3, but this time choose „Drop Shadow“ instead of „Stroke.“
5. To add a photo inside the frame, drag an image into the document and position it within the frame. You can adjust the size of the photo by selecting the „Transform“ tool (press Ctrl + T) and dragging one of the corners.
